THROUGH THOSE STORIES, OUR NONPARTISAN, NONPROFIT NEWS WEBSITE EDUCATED THE PUBLIC ON GUN VIOLENCE AND RELATED ISSUES. WE WERE ONE OF TWO MEDIA ORGANIZATIONS, FOR EXAMPLE, TO FIRST REPORT ON THE FINDINGS OF THE MOST COMPREHENSIVE ACADEMIC STUDY OF GUN OWNERSHIP AND BEHAVIORS IN TWO DECADES. OTHER COVERAGE RAISED AWARENESS OF THE LARGE RACIAL AND GEOGRAPHIC DISPARITIES AMONG SHOOTING VICTIMS. SEPARATELY, THE TRACE'S INCREASING EMPHASIS ON INVESTIGATIVE JOURNALISM BEGAN TO YIELD DIRECT BENEFITS FOR PUBLIC SAFETY. FOR INSTANCE, OUR DATA-DRIVEN REPORTING ON A RISE IN FIREARMS STOLEN FROM VEHICLES IN MULTIPLE LARGE CITIES SPURRED SEVERAL POLICE DEPARTMENTS TO ISSUE WARNINGS REGARDING UNSAFE GUN STORAGE PRACTICES.
